Subject: Second Edition of the Standard for Tank Assemblies for the Collection,  
Storage and Removal of Used Oil, CAN/ULC-S652-08

This Bulletin is a follow-up to ULC Standards Bulletin 2008-07, announcing the publication of the Second Edition of CAN/ULC-S652-08, Standard for Tank Assemblies for the Collection, Storage and Removal of Used Oil.

Underwriters Laboratories of Canada has adopted the provisions of this Second Edition of the Standard, and all new submittals will be investigated in accordance with these requirements.

The Second Edition contains new and revised technical requirements. The changes to the Standard will impact currently Listed products, and will require an industry file review to determine compliance to the new and revised requirements. A summary of requirements for this edition is included for your reference.

Since ULC has an on going Industry File Review for CAN/ULC-S601, which also affects the same Listees, the required S652 file review will be conducted as part of the S601 file review.

The effective date, for currently Listed products to comply with the new and revised requirements in the Second Edition of CAN/ULC-S652-08, will be July 1, 2010

These were previously in the Appendix which was considered informative  <b>Action Required:</b> Review files and confirm compliance with 3.3.2
4. Drop Test	4.1 exception added for utility tanks  <b>Action Required:</b> none
5. Marking	5.2 new section adding requirements for alternate methods of attachment.  <b>Action Required:</b> None
6. Installation and Maintenance Instructions	6.1 general revision – items A and D are new and will require revision of existing instructions.  <b>Action Required:</b> Review files for compliance
