Subject: Harmonization of UL & ULC Certification Directories

UL as an enterprise is striving to offer to its customers combined Canadian Certification Directories. In doing so, Underwriters Laboratories of Canada Inc. (ULC) and UL LLC are harmonizing their Canadian Certification categories in order to come up with a single Canadian Listing Directory for certified (Listed) products.

The harmonized categories will represent manufacturers who received authorization from ULC and UL LLC to use their respective marks for Canada.

There are certain administrative activities that are taking place; one such activity is harmonizing the Category Control Numbers (CCN's, an internal terminology used for tracking). In addition, Subscriber (Listee) Files / Listing text will be updated in a phased manner.

The search capability will be enhanced whereby the Authorities Having Jurisdiction (AHJ) will be able to search within one central database thereby simplifying the search for certified products for Canada.

We have initiated the harmonization for a few categories as part of a pilot.
