This Bulletin is in continuation to ULC Certification Bulletin 2014-06 issued on October 28, 2014. An Industry File Review (IFR) is presently in effect to determine compliance with CAN/ULC-S527-11, 3rd Edition. The Effective Date for the File Review is June 16, 2016 (*previously revised from June 17, 2015*). UL has received feedback from industry requesting additional time to meet the new requirements.

In response to concerns raised by some manufacturers, UL is proposing an extension of the effective date from June 16, 2016 to December 16, 2016, to allow for the time needed to transition production to the latest update of the Standard.
