Did you Know?

Driven by demand from industry, government and investors, in 2012 the Quebec Mineral Exploration Association (QMEA) sought to implement a standard to evaluate mineral exploration companies and their service providers on their responsible practices.

The Université du Québec en Abitibi-Témiscamingue (UQAT) designed the standard to promote the application of best environmental, social, and economic practices by ensuring the collaboration of various industry stakeholders.

Following the completion of the first version of the standard, QMEA and UQAT partnered with UL Solutions and adopted the standard into an ECOLOGO® Certification program.





Why is certification relevant to my business?

ULC TS-2723:2024 ECOLOGO® Certification Program for Responsible Development for the Mineral Exploration Industry

ECOLOGO® Certification for Mineral Exploration offers an opportunity to verify your responsible practices, including reduced impacts on the environment and local communities.

Certification enables your company to demonstrate its commitment to the environment, the community, and fair economic practices to investors and stakeholders. ***Advocates of the program state that additional benefits of certification may include:***

- Improved access to financing
- Improved employee motivation and work environment
- Better preparation in the event of legislative changes
- Improved relations with stakeholders which contribute to the advanced social acceptability of projects
- Reduction of project delays



How do we get certified?

Participation in the QMEA Coaching Program enables your company to prepare for the certification process.

Upon completion of the program, UL Solutions will begin the certification process with a scoping of the audit to be completed and then provide you with a commercial proposal and contract.

Once accepted, there are a few steps to complete the process:

1. The first step in the certification is a documentation review or “desktop audit” of your business processes.
2. Next is an onsite audit based on your company’s certification scope and activity during the certification period. The audit(s) are conducted at pre-selected site(s) and results are compared against the documentation review.
3. Third is a review of audit performance data and delivery of a report showing completion against requirements or areas of improvement to meet compliance and corrective actions.

The final step is the issuance of the ECOLOGO® Mark and guidelines for Mark use and messaging.





Promoting your certification

Once your ECOLOGO® Certification is complete, you can begin messaging and marketing your achievement:

1. Announce your certification to the market through communications, press releases or social media.
2. Incorporate the Mark in your facilities, your website and marketing material that showcases your certification. We ask that you do not use the Mark on the following: Company vehicles, Business Cards, Email footers/signatures. Marks should not be used in a unclear or general manner, or in ways that imply that products or companies are certified, but are not.
3. Educate your employees about the achievement.
4. Please ensure that you use the proper naming convention when talking about your Certification. In general terms, use “the ULC TS-2723:2024 ECOLOGO® Certification Program for Responsible Development for the Mineral Exploration Industry” when describing the program.
5. Promote the certification in the marketplace in advertising, at tradeshow and other events.
